SYNOPSIS

- The Vision whose Central Bank of solar reserve founding principle (similar to the BIS in Switzerland) is the creation of a new international monetary tool .
- This currency must own a universal currency virtue based on solar energy production and available solar reserves .
- This means that for each dollar issued , there is a product of equal value in the form of solar energy.
- The global transformation of clean energy needs an acceleration .
- Solar energy is now one of the cheapest world combustibile .
- The vision of the central bank of solar reserve is to incite the planet to use solar energy.
- The central bank of solar reserve contributes to lay the foundation of the global energy transition by rewarding solar energy producers with an energy reference currency (ION).
- The economic research on the central bank of solar reserve is to encourage solar electricity by rewarding solar electricity producers in order to reduce the costs of electricity production and to fund photovoltaic, wind-powered , biomass and hydropower plants projects. .
- The central bank of solar reserve provides energy producers with digital tokens based on blockchains at the rate of one ION for 100 wathours (Wh) of solar energy produced .



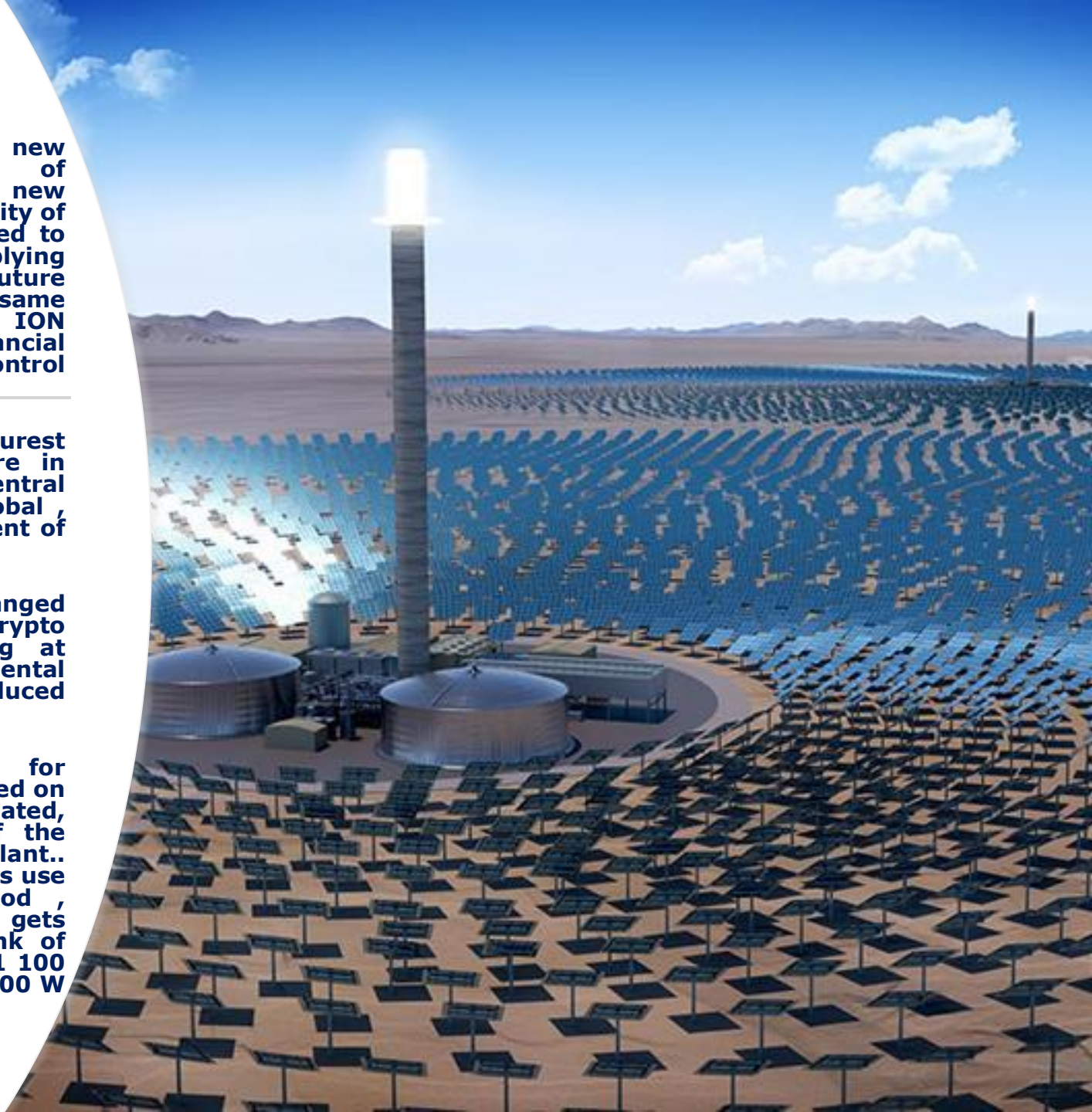


Our vision is to create a new decentralized economy of financial services of the new economy ensuring the stability of aggressive investments related to market fluctuations , supplying necessary guarantees for future projects and create at the same time an ecosystem for ION promoters and give a financial tool in order to control international exchanges.

ION will be the surest cornerstone for your future in terms of investment .The central bank of solar reserve is global , decentralized and independent of any government .

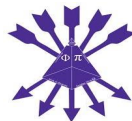
ION can be spent and exchanged in the same way as a crypto currency but it is aiming at promoting a real environmental activity : solar energy produced in a verifiable way .

Two calculation methods for subsidies are used :real, based on generated KWh, and estimated, based on a percentage of the nominal capacity of the plant.. Most producers and platforms use the real attribution method , where each kwh generated gets an ION by the central bank of solar reserve, for example $1\ 100\ W = 1,1\ kWh = 1,1\ ION$ or $100\ W = 1\ ION$.

- **To reach its goals, Ion will require additional banking licenses or partnerships in key jurisdictions in order to be able to operate in a wide range of fiduciary currencies and to facilitate cross-border transactions without the need of counterparties such as USN .**
- **ION also changes to be the reference currency .**
- **ION aims at having its own payment network like debit or credit cards , SEPA , AFRFT, TIPS and ETF transfers in order to have its own interbank exchange network , such as RIPPLE .**
- **In addition to traditional banking products , ION will provide customers and firms with innovating solutions in a low cost and the cheapest banking environment.**
- **To reach its goals , ION will be created as a private entity having for partner a top 25 bank at least .**
- **The value will be indexed to electricity production as well as gold and silver to the tune of 50 percent in guarantee which will have a stabilising role in the exchanges.**
- **Our economic model is to base on physical and not paper-based gold and silver as point of international reference to estimate market expectations on the inflation, deflation and the future value of currencies .**





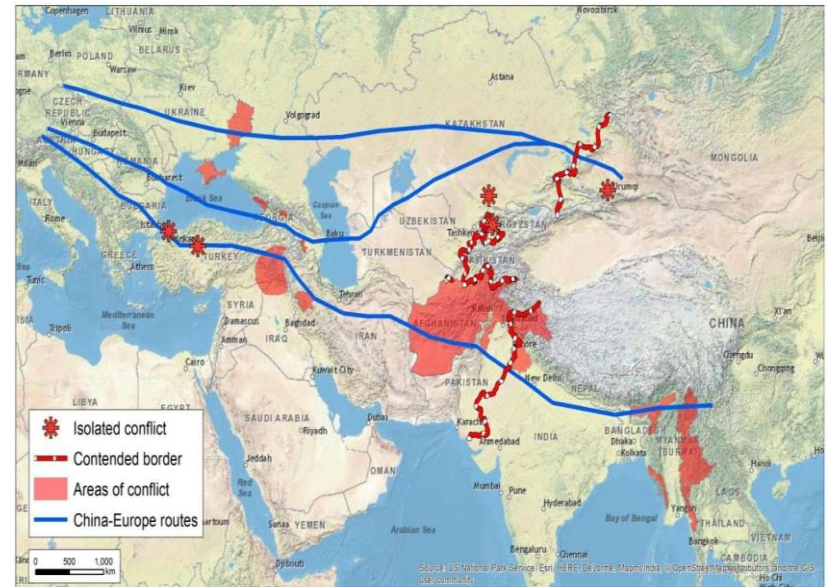
- **ION will be the surest cornerstone for your future in terms of investment .**
