DETAILED PROCEDURES FOR FUNDING FOR GLOBAL HUMANITARIAN

PROJECTS WITH AN INVESTOR (DONOR) USING AN MTN

Example: \$1,45 billion USD MTN

1. The INVESTOR donates “**MTN-EUROCLEAR (OR SIMILAR)**” to The Sovereign Church of God. (Example: MTN \$1,45 billion dollar); It is a donation as the Church is a non-profit organization. The donation will be returned to the INVESTOR at the end of the period. **The MTN**, will be transferred to the First Trustee of Humanitarian Trust (one of the Sovereign Church’s Trusts) and will be placed into trade. This transaction is completely safe and secure.
2. **The MTN** will be held for 1 year and 1 month or until humanitarian projects are completed and then returned to the INVESTOR.
3. The MTN will be evaluated between 75% and 80% of the face value (between \$1billion and \$1.1 billion dollar)
4. Once the funds are engaged, WEI (The church’s trading platform) pays interest on the MTN put into trade over **50 weeks**. This means a payment of **\$44,000,000 Dollar (Forty-four Million Dollar)** per week for 50 weeks for a total of **\$2,200,000,000 Dollar (Two billion two hundred million Dollar)** This amount will be paid into whatever BANK the INVESTOR wishes to use.
5. Furthermore, Funds of approximately **\$10,000,000,000 USD (Ten Billion Dollar)** will be available for Humanitarian Projects presented by Ecko Online (along with the investor) and WEI. These Funds are paid out as project contracts are presented.
6. A tax-free charitable receipt for \$2,200,000,000 Dollar will be provided.

PROCEDURES STEPS

1. INVESTOR signs a **JOINT VENTURE AGREEMENT** with **ECKO ONLINE** for a 50/50 sharing of profit and for Humanitarian Funds available – **signed-notarized.**
2. INVESTOR sends **KYC** – **signed and notarized.**
3. INVESTOR sends an **Affidavit of Donation** – **signed and notarized.**
4. INVESTOR signs **JOINT VENTURE AGREEMENT WITH WEI** – **signed and notarized.**
5. Once **JVA is signed**, The Sovereign Church will send Certificate of Donation and Deed of Agreement – will need to be **signed and notarized.**
6. The final step is for the INVESTOR to SEND **THE MT 542 MTN** TO THE BANK DESIGNATED BY THE PLATFORM, IN FORM OF “DONATION TO THE CHURCH”
7. **Payments begin within the following 2 weeks, AFTER RECEPTION OF MT542 / VERIFICATION BANK.**
